## HIGHLIGHTS

- The number of structures demolished or seized increased from 60 in January to 91 in February 2022.
- Six of the structures targeted in February were funded by the EU or its Member States and five others are at risk of demolition.
- The high proportion of buildings demolished by their owners in East Jerusalem continues.

## OVERVIEW

In February, the Israeli authorities demolished, forced people to demolish or seized 91 Palestinian-owned structures across the West Bank, including East Jerusalem. This resulted in the displacement of 102 people, including 43 children, and affected the livelihoods, or access to services, of over 700 others. All but two of the structures were targeted for lacking building permits, which are nearly impossible for Palestinians to obtain. The monthly average number of people displaced and of structures targeted in the first two months of 2022 is approximately the same as the 2021 average, which witnessed the highest number of demolitions recorded in the West Bank, including East Jerusalem, since 2016.

The incident resulting in the most structures targeted occurred on 1 February, near Al Jalama checkpoint in Jenin where the Israeli authorities seized 22 market stalls (15 per cent of all structures targeted this month). These stalls supported the livelihood of 85 people, including 35 children.


Another 17 structures in seven Area C communities were demolished on the basis of Military Order 1797, which provides for the demolition of structures deemed 'new', as soon as 96 hours after the issuance of a notice, leaving little possibility for legally challenging the order. These included six under-construction homes, and 11 livelihood- and service-related structures. Since coming into effect in July 2019, Military Order 1797 has served for the demolition of 191 structures in Area C.

Nine of the structures targeted in February were in four herder communities located in areas designated by the Israeli authorities as 'firing zones' for military training, which comprise nearly 30 per cent of Area C. In two such communities, Khallet Athaba' (in Massafer Yatta, Hebron) and Arab ar Rashayida al Barriya (in Bethlehem), the Israeli authorities demolished four water cisterns, an agricultural structure and a latrine, and damaged a water network.

In total, six of the structures targeted in February in Area C were funded by the EU or its Member States, for a total value of about 21,600 euros. Additionally, over 170 olive saplings which were provided with EU funding to farmers in three communities, were



destroyed, uprooted, or stolen by people known or believed to be Israeli settlers. Finally, five structures funded by the EU or its Member States for 68,400 euros, including a school in the Ras at Tin Bedouin community in Ramallah, received renewed demolition orders. Currently, there are 54 schools in Area C and East Jerusalem with pending demolition or stop-work orders.

Eight structures, including four homes, were demolished in East Jerusalem: three by the Jerusalem Municipality and five by the owners, following the issuance of demolition orders, to avoid financial penalties and the destruction of their belongings.

Also in February, the Israeli authorities demolished, sealed, or damaged on punitive grounds, three homes in Silat al Harithiya village (Jenin) and one in the Shu'fat refugee camp (East Jerusalem), displacing four Palestinian families, comprising 21 people, including ten children. In the Jenin incident, one home was targeted and two others, in the same building, were damaged. The targeted properties were home to the families of Palestinians prosecuted for the killing of two Israelis in November and December 2021.






